Fees You Might Owe

Depending on your insurance, you may be responsible for a portion of the fees, as a copay, coinsurance, deductible or spend down.

We will tell you in advance if you will owe any fees for the services you receive.

When you are responsible for partial payment, you will receive an invoice at least monthly for the amount you owe.

Private Pay Agreements

Accend accepts private pay clients and charges our usual and customary rates for all services.

If you are uninsured for any service listed here, you may make arrangements to receive the service in a private pay agreement.

Sliding Fee Scale Services

Accend will not deny requested health care services, and shall not discriminate in the provision of services to an individual because the individual is unable to pay for the services.
